Drug Screen (not required for CWO) <ul style="list-style-type: none"> 10-panel drug test required Must be done at LabCorp or Quest Diagnostics facility Appointment times Monday-Friday, 10 a.m. - 2 p.m. 			
CPR Certification (Basic Life Support) <ul style="list-style-type: none"> Must be renewed every two years BSN & MSNE: American Heart Association BLS ONLY RN-to-BSN, RN-to-MSN, All Graduate/Certificate Programs: American Heart Association OR American Red Cross BLS 			
Td OR Tdap (Tetanus) <ul style="list-style-type: none"> Must be renewed every 10 years 			
MMR (Measles, Mumps, Rubella) <ul style="list-style-type: none"> Two-dose vaccine or positive titer 			
Varicella (Chicken Pox) <ul style="list-style-type: none"> Two-dose vaccine or positive titer History of disease not accepted 			
Hepatitis B <ul style="list-style-type: none"> Two-step schedule (Hepislav) or three-dose series AND positive titer within 24 months Doses 1 and 2 one month apart, third dose 6 months later 			
TB (Tuberculosis) <ul style="list-style-type: none"> QuantIFERON Gold or two-step skin test (within 12 months AND a UMB Student Annual TB Risk Screening Questionnaire) If positive skin test result, must provide chest X-ray (valid for 5 years) and TB questionnaire (renewed annually) Requires annual renewal

Flu Vaccine (Influenza) <ul style="list-style-type: none"> • Must show proof of current season's vaccine or submit Influenza Declination Form • Current season's flu vaccine must be uploaded by Oct. 1 • Requires annual renewal • Clinical sites may not accept UMB-approved exemptions 			
COVID-19 Vaccine <ul style="list-style-type: none"> • Upload proof of two-dose Pfizer or Moderna or one-dose J&J primary vaccine series or bivalent booster • Clinical sites may not accept UMB-approved exemptions 			
MCV <ul style="list-style-type: none"> • If the answer is "no," no further action required • If answer is "yes," must provide proof of meningococcal vaccine or submit a waiver

ACLS (Anesthesia and AGACNP/CNS students) <ul style="list-style-type: none"> • Must be renewed every two years
